## BUSINESS TAX RECEIPT FEE SCHEDULE

The following applicable fees apply to Business Tax Receipts in the City of Mount Dora. All Business Tax Receipts expire on September 30<sup>th</sup> of each year. Invoices for renewals will be mailed on August 1<sup>st</sup> and payment is due no later than October 1<sup>st</sup>. After December 1<sup>st</sup>, late fees will apply.

### LATE FEES

<b>60 TO 90 DAYS</b>	<b>\$ 3.00</b>	<b>(After December 1<sup>st</sup>)</b>
<b>MORE THAN 90 DAYS</b>	<b>\$ 6.00</b>	<b>(After January 1<sup>st</sup>)</b>
<b>OVER 150 DAYS</b>	<b>See *Note</b>	<b>(After May 1<sup>st</sup>)</b>

**\*NOTE:** Payment not received after 150 days from the date of the initial notice of tax due and who does not obtain the required local Business Tax Receipt is subject to civil actions and penalties, including court costs, reasonable attorney's fees, additional administrative costs incurred as a result of collection efforts, and a penalty of up to \$250.00.
