- Proof that Registered Participant Establishment is located in the Downtown Entertainment District Boundary.
- Copy of City of Mount Dora Business Tax Receipt (Occupational License).
- Proof in the form of photograph, image, or other acceptable format, showing the required marking to identify the Registered Participant from which the open alcoholic beverage was purchased. Container must be plastic and may not exceed sixteen (16) ounces in size.
- Copy of State of Florida Department of Business and Professional Regulation, Division of Alcoholic Beverage and Tobacco License.
- A copy of your current Liability Certificate of Insurance providing coverage of not less than \$1,000,000.00 for property damage, bodily injury, or death payable to any one person and \$2,000,000.00 for property damage, bodily injury or death when totaled with all other claims or judgments arising out of the same incident or occurrence which lists the “City of Mount Dora, 510 N Baker Street, Mount Dora, FL 32757” as the certificate holder.

NOTE: This registration must be renewed annually with updated information provided as required by the City.

INDEMNIFICATION

In consideration of the privilege to participate in the City of Mount Dora Downtown Entertainment District, at the above stated address, the Establishment Owner (Registered Participant) does hereby indemnify and hold harmless the City, its officers, employees, and the like, from any and all claims, causes of action, liabilities, damages, costs, including attorney’s fees, arising from or in any way related to the Establishment Owner’s (Registered Participant’s) participation in the Downtown Entertainment District and the activities permitted therein.

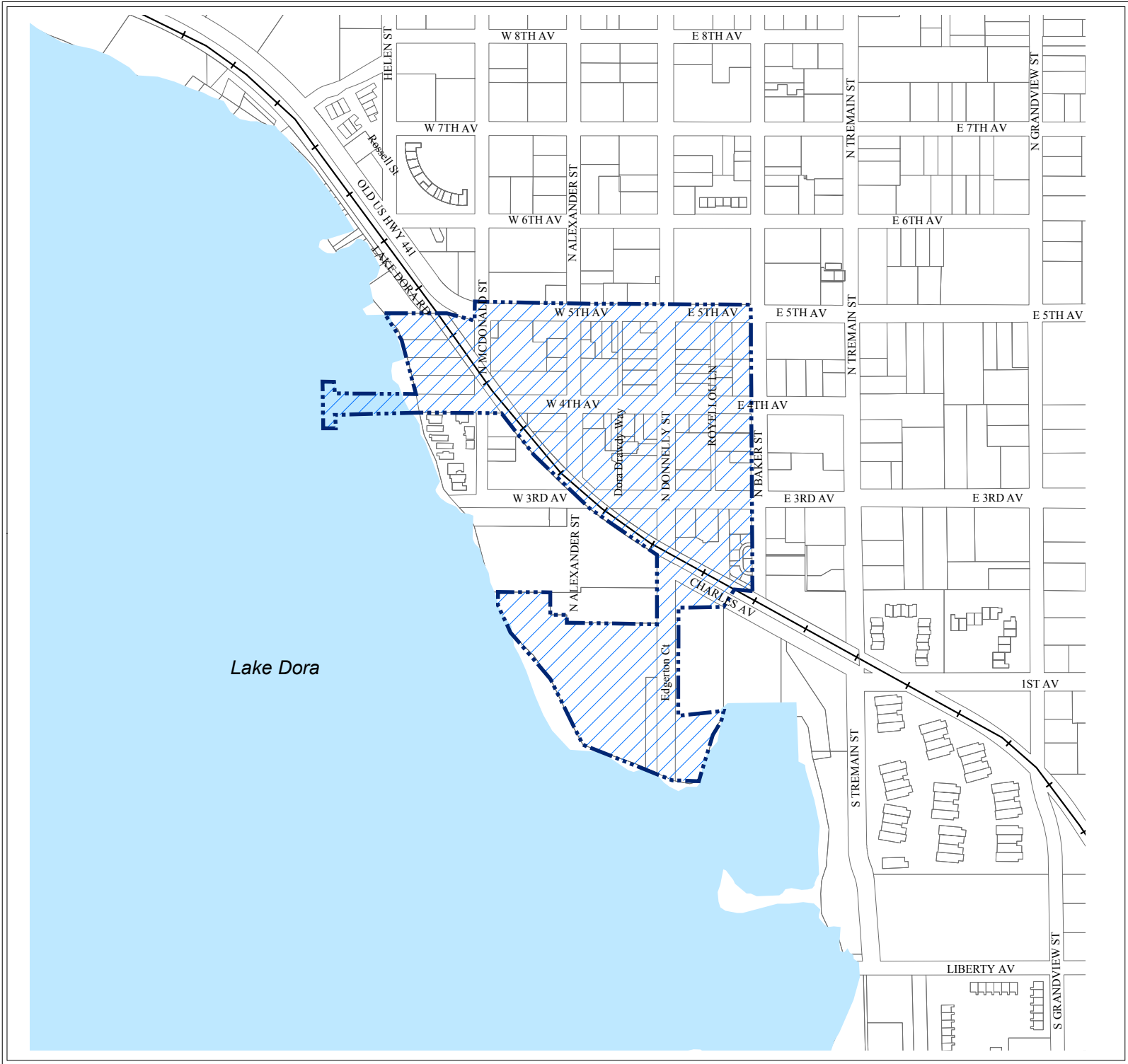
